# 2011 JCI Plan of Action – Summary

#### Introduction

By providing development opportunities that empower young people to create positive change, JCI is on a mission to change the world by transforming communities and changing lives. In 2011 the organization embarks on an exciting journey to position JCI as a global organization with the ability to impact the world. JCI will take action to accomplish its vision of being the leading global network of young active citizens.

#### A World of Citizens: JCI and Human Security

The 2011 Plan of Action is inspired by a new era – an era in which the destiny of the world is being defined by citizens rather than nations. In a post Cold War 21st century, with increasing globalization, and where people are exposed to threats that cannot be resolved by unilateral efforts of nations, young active citizens will have to take initiative to ensure that communities are developed and progress is made beyond national boundaries and government bureaucracies.

The term "Citizens Initiative" has been used to define the notion that positive change in the world will be brought about by the action of individuals rather than the action of nations or states. As a forward-thinking organization, JCI shall embrace the future in 2011 and urge members to be the true active citizens by taking initiative to lead the world to a better place. As active citizens, we can no longer subscribe to the notion that national security shall be provided by governments, but we must ensure the security of every human being from want or fear.

In recent years, the United Nations has begun to address the concept of human security, which, simply put, is a concept that seeks to ensure the security of every human being in terms of food, health, the environment, personal safety, community and politics. The perspective of human security emerged because nations no longer have the ability to deal with issues that face the security of individuals unilaterally. Human security means protecting the vital core of human lives in a way that enhances human freedom and human fulfillment. It works to free people of their fears as they relate to conflicts, terrorism, natural disasters, environmental degradation, infectious disease and economic crisis. It relates to the ability to elevate people out of poverty, illiteracy, poor health and the lack of vital social services.

These problems continue to prevail because governments – whether in developed or emerging economies – cannot sufficiently satisfy the wants of the people. The old top-down approach to human development from government has proven insufficient. It will take a bottom-to-top grassroots efforts implemented by citizens like JCI members to meet these wants. We are responsible for the future of our communities, our countries and the world at large. At no time has our mission, which empowers young people to create positive change, been more relevant than now. At no time has our action been more urgent.

With a vision to becoming a leading global organization, we must reaffirm our commitment to our mission and as one global team with a unified sense of purpose, embark on an ambitious journey to lead the world to a new era.

To embark on this ambitious journey we have defined three main goals for ourselves as an organization.

# 1. To build a truly global organization with shared values and common goals

Unquestionably we have a very diversified membership from diversified communities. We no doubt face different challenges from community to community, continent to continent, but while our faces and our challenges may be different, we represent one human race, living in one global village. There are common problems that we face that we must address globally.

Over 180 world leaders agree that the United Nations Millennium Development Goals (MDGs) are an ideal list of challenges that need to be overcome. As young people embracing the future, we must address the MDGs but we must also look beyond the MDGs to a world that will always have problems to solve. This is a responsibility that we must accept. We are and must continue to build one global team in 2011 that will rid the world of its challenges. As a global team, we will strengthen

our partnership with the United Nations Foundation to fundraise, create awareness and fund the purchase and distribution of bed nets to see an end to malaria deaths.

## 2. To build global partnerships for development:

While building global partnerships for development is one of the MDGs, it is important for us to identify partners who share common values, and together we can work to implement solutions that will create positive change in every JCI community. We will engage and lead members, businesses and governments to adhere to the 10 principles of the UN Global Compact. As many JCI members around the world are active in small- and medium-sized enterprises, JCI has an important role to fill in our partnership with the UN Global Compact. We will lead all sectors of society by implementing the JCI Better World Framework to impact communities around the world. As we continue to build our international partnerships, we will strengthen JCI's reputation in the global arena, furthering our vision to become the leading global network of young active citizens.

3. To foster active citizenship through the Citizens Initiative
In the words of the Founder of the Junior Chamber movement, Henry
Giessenbier, "From within the walls of the soul of this organization,
wherein the foundation of character and citizenship are laid, we hope a
message will come forth in the sometime of tomorrow that will stir the
people toward the establishment of a permanent and everlasting
peace." In 2011 the organization will stir people of the world to the
establishment of permanent and everlasting world peace in the Japanese
philosophy of OMOIYARI. While everlasting peace may be unrealistic, as
active citizens we must take action to rid the world of its numerous
conflicts. It will take the commitment not only of JCI members, but also
education and awareness of every young person to build a better world.

To realize the aforementioned goals, this plan is divided in the seven key areas recommended by the 2008 Strategic Planning Committee as a way to stay aligned and progressively build a truly global organization.

## i. JCI Mission, Vision and Values

**Objective:** To position JCI as a vision-driven organization with a core set of values that is exemplified in every undertaking of the organization.

#### **Action Steps:**

 Implement the JCI Better World Framework to communicate the essence of the JCI Mission

- Publish an annual report as a communication tool for external partners and internal constituents, focusing on the accomplishments of the JCI Mission, a steady movement towards our vision and emphasis on the values of the organization
- Implement an external communication strategy that will position JCI as a leading global organization that will lead various sectors towards creating positive change

**Responsibilities:** JCI members, Local and National Organizations, JCI Board of Directors, JCI World Headquarters Staff.

**Time frame:** January 1 to December 31, 2011.

## II. Membership – Recruitment and Retention

**Objective:** To ensure members are motivated to play an essential role in developing their communities and develop skills that will lead them to make a difference at every level of society.

## **Action Steps:**

- Use the JCI website and other avenues of communications to motivate and inspire members
- Use the Impact of One Campaign to encourage members to take ownership of recruitment and increase the impact of the organization.
- Update, print and distribute the JCI Local Organization toolkits
- Implement the JCI Better World Framework as a platform for members to take action in their communities, hence attracting young people to join the organization
- Identify communities and create new JCI Local Organizations in existing National Organizations
- Identify new countries in which new JCI National Organizations will be created
- Fix growth objectives at every level of the organization to attain overall growth
- Innovate growth strategy to increase membership to 300,000 in 3 years

**Responsibility:** JCI members, Local Organizations, National Organizations, JCI Board Members, JCI World Headquarters Staff.

Time frame: January 1 to December 31, 2011

# **III. JCI World Headquarters Services**

**Objective:** To ensure that the JCI World Headquarters provides members with tools and guidance that will facilitate their ability to create impact in their communities.

# **Action Steps:**

- Redeploy resources at Headquarters to suit the needs of the organization
- Lead the implementation of the JCI Better World Framework across the organization by developing the tools and material necessary for its implementation
- Continue to enhance and optimize performance of the JCI website.
- Develop a communication strategy aimed at attracting potential members, partners and sponsors to be engaged in JCI activities and to position JCI as a leading global organization.
- Enhance collaboration with key partners and extend such collaboration to new partners using the JCI Better World Framework. Notable JCI partners include the United Nations and its agencies, the International Chamber of Commerce (ICC), AIESEC, the Hanns Seidel Foundation and Cordaid
- Continue the commitment to deliver 1,000,000 insecticide-treated bed nets by 2015 in collaboration with the United Nations Foundation.
- Continue to promote and encourage members to carry out projects aligned with the UN Millennium Development Goals
- Promote and facilitate access to the small and medium size enterprises to join the UN Global Compact. Further develop a training program in this regard and aim to sign up 5,000 small and medium size businesses with the UN Global Compact
- Implement the resolutions of the 2010 JCI Global Partnership Summit by bringing together more of the civil society, governments and corporations in the 2011 JCI Global Partnership Summit

Responsibility: JCI Board of Directors, JCI World Headquarters Staff.

Time frame: January 1 to December 31, 2011

#### IV. JCI Programs:

**Objectives:** To revitalize JCI Programs, making them more relevant to JCI activities.

#### **Action Steps:**

- Develop JCI Programs to be aligned with JCI Better World Framework
- Develop the JCI Speaking Competition to be run in high schools and to engage members in relevant development issues in their communities
- "To stir the people toward the establishment of a permanent and everlasting peace" words from the JCI Founder Henry Giessenbier will be the theme of the 2011 JCI World Speaking competition. This theme is

- intended to reinforce the concept of the Citizen's Initiative and highlight the ability of young people to make a difference in the future of the world
- Implement a new JCI Awards system that is relevant, demands higher standards and serves as a showcase of the organization's activities both internally and externally
- Review and begin the implementation of a new JCI Twinning program that encourages and enhances international collaboration and exchange
- Prioritize the continuous promotions of the JCI Programs

**Responsibility:** JCI members, Local Officers, National Officers, Appointees, JCI Board of Directors, JCI World Headquarters Staff.

Time frame: January 1 to June 30, 2011

## V. JCI Events

**Objectives:** To use JCI Area Conferences and World Congress to address regional and global issues and appeal to all sectors of society.

# **Action Steps:**

- Implement a new platform for JCI Area Conferences to propagate the JCI Better World Framework
- Use JCI Area Conferences as a way to engage not only JCI members but also various pillars of society towards finding solutions to regional and global issues
- Use JCI Events as a showcase for best practices and to advance the strategic vision and mission of the organization
- Organize a 2011 JCI Global Partnership Summit as the main event of the year in New York that will position JCI as leading the world to a better place
- Further develop the JCI Academy to provide increased development and networking opportunities for future leaders of the organization.
- Begin planning for the celebration of the 100<sup>th</sup> anniversary of JCI

**Responsibility:** All JCI Area Conference Organizing Committees, JCI members JCI Board of Directors, JCI World Headquarters Staff.

**Time frame:** January to June 2011 for JCl Area Conferences and JCl Global Partnership Summit and January to December for the JCl World Congress.

# VI. JCI Finances and Revenue:

**Objectives:** To review the JCI budget to reflect the short-term and long-term objectives of the organization but also to move the organization away from total dependence on traditional sources of finances such as membership dues and the JCI Senate.

# **Action Steps:**

- Use the JCl Better World Framework to build partnerships that will lead to an increase in revenue for JCl
- Increase revenue through an increase in the number of Senators
- Review JCI Officer travel to reduce cost and improve efficiency
- Revise and procure popular JCI merchandise to generate revenue
- Review and evaluate the effectiveness of the current JCI dues structures for future recommendations
- Review and implement an effective promotion plan for the JCI Foundation, both internally and externally

**Responsibility:** JCI members, JCI Local and National Officers, JCI Board of Directors, JCI World Headquarters Staff.

Time frame: January 1 to June 30, 2011

# VII. JCI Training:

**Objective:** To develop JCI Training courses that will build members into exemplary active citizens by identifying societal problems and taking action to find solutions.

## **Action Steps:**

- Develop new JCI Training Courses that will inspire personal and collective responsibility towards development
- Enhance performance of the JCI online training tools
- Develop JCI online training capability
- Continue to improve the online administration of the JCI Training Certification program
- Realign JCI Training with JCI Better World Framework to ensure that every JCI Local Organization receives the necessary training to inspire its members to implement the framework
- Use the JCI Area Conferences as a medium to promote the new JCI Training Courses
- Develop a Social Responsibility training program for small and medium sized companies that focuses on the implementation of UN Global Compact Principles

**Responsibility:** JCI Local and National Officers, JCI Board of Directors, JCI World Headquarters Staff.

Time frame: January 1 to December 31, 2011

**Conclusion:** Our vision to be the leading global network of young active citizens can only be accomplished if we take our place on the international scene.

Through JCI programs, projects and events, JCI members will take action to lead the world to overcome the greatest challenges of the millennium. Our Founder Henry Giessenbier spoke about stirring "the people toward the establishment of a permanent and everlasting peace." It is this message that will guide the organization in 2011, and our actions will stir the citizens of the world toward the establishment of a permanent and everlasting peace.
